**Broker Statement**

Client was uncertain whether to proceed with a lump sum investment or implement a periodic contribution strategy. In the absence of a defined investment mandate, funding approach, or client authorization to proceed, no specific investment recommendations were made or implemented at the time of initial funding. The client did not provide further direction or engage in the investment planning process for approximately 18 months following initial funding, during which time the assets remained in cash. Upon re-engagement, the client raised concerns regarding the uninvested cash balance. All fees collected were subsequently reimbursed.
