### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

[CUSTOMER] DID NOT ACCEPT THE TERMS OF THE REPAYMENT AND FILED FOR ARBITRATION WITH FINRA. MR. HELMS IS A MANAGING PARTNER OF EXETER FINANCIAL AND WAS A REGISTERED REPRESENTATIVE WITH BMA SECURITIES.
