**Broker Statement** I WAS DISCHARGED FROM J.P. MORGAN SECURITIES LLC ON 1/16/15 FOR WHAT WAS DETERMINED TO BE A NON-SECURITIES RELATED CORPORATE CODE OF CONDUCT VIOLATION. THE VIOLATION OCCURRED AT AN EMPLOYER SPONSORED OFF-SITE CHRISTMAS PARTY AT A LOCAL RESTAURANT. DURING THE PARTY, DINNER AND DRINKS WERE PROVIDED BY MY EMPLOYER, ALL EMPLOYEES WERE ALSO ASKED TO PARTICIPATE IN A "WHITE ELEPHANT" GIFT EXCHANGE. MOST OF THE GIFTS



EXCHANGED WERE GAG GIFTS OR BOTTLES OF WINE AND ALCOHOL. WHEN LEAVING THE RESTAURANT WITH MY CO-WORKERS, JOKINGLY, I GRABBED A BOTTLE OF WINE FROM A DECORATIVE DISPLAY AT THE EXIT OF THE RESTAURANT AND SAID TO ONE OF MY PEERS "HERE'S THAT BOTTLE OF WINE YOU WANTED FROM THE GIFT EXCHANGE". I WAS REFERRING TO THE BOTTLE OF WINE THAT HAD BEEN TAKEN AWAY FROM HER DURING THE "WHITE ELEPHANT" GIFT EXCHANGE. I BELIEVED THAT THE DISPLAY BOTTLE WAS EMPTY AS IT WAS MERELY A DECORATION AND I LEFT IN THE PARKING LOT OUTSIDE OF THE RESTAURANT. OVER A MONTH LATER I WAS CONTACTED BY MY EMPLOYER AND ASKED ABOUT WHAT OCCURRED. I WAS 100% HONEST AND FORTHCOMING BUT HAD NO WAY TO PROVE THE BOTTLE WAS EMPTY OR THAT IT WAS LEFT IN THE PARKING LOT. WHEN DISCUSSED WITH MY DIRECT MANAGER IT HAD ALREADY BEEN DETERMINED THAT WHAT OCCURRED VIOLATED THE COMPANY'S CODE OF CONDUCT POLICY AND I WOULD BE DISCHARGED. I WAS NEVER CONTACTED BY ANY TYPE OF LAW ENFORCEMENT, NO CHARGES WERE EVER FILED NOR WAS I EVER CONTACTED BY THE RESTAURANT ABOUT WHAT TOOK PLACE. MY ACTIONS WERE REGRETTABLE AND COMPLETELY OUT OF CHARACTER AND I TOOK FULL RESPONSIBILITY FOR THIS BAD ATTEMPT AT HUMOR AND MOMENTARY LACK OF JUDGMENT.
