### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

**Allegations:** CLIENT WAS REFERRED TO ME BY HIS BROTHER, A SF ASSOCIATE, AS HE KNEW I HAD A LOT OF SERIES 6 EXPERIENCE. CLIENT HAD HIS POLICY TRANSFERRED TO ME, AND APPROACHED ME WANTING A "HIGHER" PAYING POLICY THAN WHAT HE HAD--A REGULAR UL. I PRESENTED HIM A VUL OPTION, AND MET WITH HE, HIS WIFE, CPA & ATTNY. ALL AGREED IT WAS A SUITABLE PRODUCT. HE CALLED MONTHS LATER, AND SAID HE THOUGHT HE WANTED TO GO BACK TO HIS OLD UL. HE STATED HE WAS NOT UPSET WITH ME...HE JUST WANTED THE OLD POLICY BACK. TO AID HIM IN MAKING A DECISON, I RECOMMENDED THAT WE SET UP ANOTHER MEETING WITH THE ABOVE ADVISORS, AND MY AFE. ALL AGREED AGAIN, THAT THE UL TO VUL WAS AN APPROPRIATE COURSE OF ACTION. MONTHS AFTER THAT, HE CALLED AND SAID HE WANTED TO REVERT BACK TO HIS ORIGINAL UL. I NOTIFIED LIFE CO, WHO ASKED THAT HE WRITE A NOTE TO THAT EFFECT. STATE FARM EVENTUALLY ACCOMODATED HIM AND REVERSED THE POLICY. MONTHS PASSED, AND HE HAD SPOKEN TO AN ATTNY, AND FINANCIAL ADVISOR. HE CAME BACK AND WANTED "LOST INTEREST" FROM THE TIME, WHEN SF WAS DECIDING WHAT TO DO. IN ADDITION, IN ALL OF HIS LETTERS TO SF, HE REFERRED TO THE POLICY AS AN "INVESTMENT". SF ASSUMED I HAD REFERRED TO THE POLICY AS AN "INVESTMENT", WHICH I NEVER DO IN THE COURSE OF MY DAY TO DAY ACTIVITIES!! DUE TO A THREAT OF LEGAL ACTION, SF SETTLED WITH HIM, IN EXCESS OF \$ 25,000. I FEEL THAT THIS U4 DISCLOSURE IS AN UNFAIR MARK ON MY RECORD, SINCE HE KNEW HE WAS BUYING A LIFE POLICY (HE HAD AN EXAM FOR THE INCREASED COVERAGE AMOUNT. IN FACT, HIS WIFE WAS PUSHING FOR INCREASED
