Broker Statement

This was an individual client that was a long-time business owner in a family agricultural business. He had accumulated a net worth in excess of 4 million dollars. He was an experienced investor with a portfolio that included fixed income accounts, individual stocks, annuities, mutual funds, multiple business - partnerships, farm ground, and real-estate investment trusts (REITS). Based on the clients vast and long-standing investment experience, net worth, and meeting all of the guidelines he was deemed to be an accredited investor and suitable to purchase GPB Automotive for his investment portfolio. The amount of the investment represented a very small fraction of the clients overall net worth. In addition, I was not individually named in the claim made by the client rather it was made against my broker dealer FSC Securities. FSC Securities acted on their own behalf without any contribution or involvement from me in any capacity. FSC decided to settle the claim for \$14,000 and there was no contribution on my behalf. Based on all of these factors this was a suitable investment and I deny any and all allegations made by the client.
