IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Employing firm when activities occurred which led to the complaint: Bankers Life and Casualty Company (BLC)

Allegations: On April 13, 2017, Bankers Life and Casualty Company (BLC), an affiliate of Bankers Life Securities, Inc. (BLS) received an email from a representative of Edward Jones' (EDJ) regarding certain account withdrawal paperwork obtained by EDJ from [Customer Name] ([Customer Name]), a mutual client of BLC and EDJ . EDJ contacted BLC, at the request and with the authorization of [Customer Name] to inform BLC that [Customer Name] had informed EDJ of his belief that the withdrawal paperwork, purportedly signed by [Customer Name], was a forgery. Upon its own investigation of the matter, BLC determined that Robert Donati (Donati), a BLC agent and registered representative of BLS, had modified withdrawal paperwork originally signed by [Customer Name] in 2013 to process a withdrawal on April 10, 2017. While [Customer Name] confirmed to BLS that he requested the withdrawal, he did not have knowledge or authorize Donati to make such modification or use such form. BLC obtained two affidavits from [Customer Name] alleging forgery and unauthorized signature, dated April 26, 2016 and May 11, 2017, respectively. BLC notified BLS of the findings of its investigation on June 14, 2017.
