**Allegations:** THE CUSTOMER HAS ASSERTED NUMEROUS CLAIMS AGAINST FIDELITY RELATING GENERALLY TO CERTAIN PROGRAMS OFFERED ITS CUSTOMERS. IN ADDITION TO HIS PRIMARY CLAIM AGAINST FIDELITY, THE CUSTOMER ALSO CLAIMS THAT INVESTMENT ADVICE ALLEGEDLY GIVEN TO HIM BY MR. HANNA CONCERNING THE PURCHASE OF AN INDEX TRACKING STOCK WAS NOT SUITABLE. THE CLAIM AGAINST MR. HANNA IS ONLY A SMALL PERCENTAGE OF THE ALLEGED DAMAGES STATED BELOW.

THE FIRM INVESTIGATED THE CUSTOMER'S ALLEGATIONS IN THIS MATTER AND CONCLUDED THAT THEY ARE WITHOUT MERIT. FIRST, THE CUSTOMER'S FIDELITY ACCOUNTS ARE SELF-DIRECTED BROKERAGE ACCOUNTS, WHICH MEANS HE IS RESPONSIBLE FOR ALL DECISIONS RELATING TO HIS INVESTMENTS. SECOND, THE CUSTOMER ALONE MADE THE DECISION AS TO WHICH SECURITIES HE CHOSE TO PURCHASE, AND WITH RESPECT TO THE INDEX TRACKING STOCK AT ISSUE, FIDELITY'S RECORDS REFLECT THAT THE CUSTOMER SPECIFICALLY STATED THAT HE WANTED TO INVEST IN AN EQUITY THAT TRACKED THE NASDAQ. MR. HANNA DENIES HAVING RECOMMENDED THE PURCHASE OF THE INDEX TRACKING STOCK. FINALLY, THE CUSTOMER SELECTED CAPITAL APPRECIATION AS HIS INVESTMENT OBJECTIVE. ACCORDINGLY, THE FIRM DOES NOT BELIEVE AN ADJUSTMENT IS WARRANTED IN THIS INSTANCE.
