IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations:	CLIENT STATES SHE OWNED AN ANNUITY VALUED AT \$50K WITH A DEATH BENEFIT OF \$61,196. CLIENT INDICATES SHE WAS COUNSELED BY THE FINANCIAL ADVISOR TO SELL THE ANNUITY AND ALLOWED HIM TO PURCHASE TAX FREE BONDS. CLIENT STATES SHE WAS CONCERNED ABOUT THE TAX IMPLICATIONS AND WAS ASSURED BY THE FINANCIAL ADVISOR THAT THE DOLLARS FROM THE SALE WOULD BE ROLLED INTO OTHER TAX FREE INVESTMENTS. CLIENT INDICATES THE FINANCIAL ADVISOR GAVE HER INCORRECT ADVICE AND IS NOW INCURRING \$7,500 IN INCOME TAX FROM THE SALE OF THE ANNUITY. CLIENT BELIEVES SHE IS ENTITLED TO RECEIVE DAMAGES EQUAL TO THE TAX LIABILITY.

Broker Statement

EDWARD JONES WAS NOT BROKER/DEALER ON THIS ANNUITY AND, THEREFORE, THE INFORMATION WE WERE ABLE TO OBTAIN WAS VERY LIMITED. ACCORDING TO THE FINANCIAL ADVISOR, CLIENT INITIATED CONTACT WITH HIM ABOUT HER ANNUITY, AS SHE WAS UNHAPPY WITH THE FEE(S). IT IS OUR UNDERSTANDING CLIENT HAD HER MONEY INVESTED IN ANNUITIES FOR A LONG TIME, AND SHE COULD NOT RECALL WHAT SHE ORIGINALLY INVESTED.

FINANCIAL ADVISOR INDICATED HE INFORMED CLIENT THAT SURRENDERING THE ANNUITY COULD CREATE A LARGE TAX BILL AND ENCOURAGED HER TO KEEP THE METLIFE ANNUITY. FINANCIAL ADVISOR STATED CLIENT TOLD HIM SHE WANTED OUT OF THE ANNUITY AND HE INFORMED CLIENT TO CONTACT METLIFE DIRECTLY. IT WAS CONFIRMED BY METLIFE THAT THE CLIENT CONTACTED THE COMPANY TO SURRENDER THE ANNUITY AND A FORM WAS COMPLETED BY CLIENT (WITH SIGNATURE). WHILE WE ARE NOT PRIVY TO THE CLIENT'S DISCUSSION WITH METLIFE, IT IS TYPICAL FOR AN INSURANCE COMPANY TO PROVIDE A DISCLAIMER ABOUT TAXES AND IT WOULD APPEAR THERE WAS A NOTATION ABOUT TAXES ON THE SURRENDER FORM AS CLIENT SELECTED NOT TO WITHHOLD TAXES. AS A RESULT OF THE SURRENDER OF THE ANNUITY, CLIENT WOULD HAVE RECEIVED A 1099-R FROM METLIFE FOR 2011. THE 1099-R PROVIDED INFO FOR THE CLIENT'S TAX PREPARATION. IN REGARD TO DISCUSSING REINVESTMENT OPTIONS WITH FINANCIAL ADVISOR, HE INDICATED TAX-FREE OPTIONS WERE DISCUSSED; HOWEVER, HE NEVER PRESENTED THE OPTIONS AS A TAX-FREE EXCHANGE FROM THE ANNUITY. OUR RECORDS REFLECT CLIENT DEPOSITED A CHECK FROM METLIFE TO THE EDWARD JONES ACCOUNT ON 2/22/ 11 IN THE AMOUNT OF \$49,004.49. OUR RECORDS FURTHER REFLECT CLIENT INVESTED \$47,782.56 IN THE FIRST TRUST TAX EXEMPT MUNICIPAL INCOME TRUST ON 3/9/11. IN REGARD TO FINANCIAL ADVISOR'S REACTION TO THE CLIENT'S TAX SITUATION, HE DID APOLOGIZE FOR ANY MISCOMMUNICATION BETWEEN THE CLIENT, HIM AND METLIFE. IF CLIENT CONTINUES TO HAVE CONCERNS ABOUT THE DISCLOSURE OF HER POTENTIAL TAX LIABILITY, WE SUGGESTED SHE CONTACT METLIFE DIRECTLY. WE RESPECTFULLY DENIED CLIENT'S REQUEST FOR DAMAGES RELATING TO THE TAX LIABILITY IN SURRENDERING THE ANNUITY.

AFTER ADDITIONAL REVIEW AN OFFER OF \$6000.00 WAS EXTENDED AND ACCEPTED BY THE CLIENT ON MARCH 1, 2013.
