<b>Broker Statement</b>	This was a bizarre charge and completely inconsistent with my character and long-time previously clean criminal record. I was preparing the wood for a "sit and relax by the fire" kind of fire on my property. The wood for the fire was wet, and I was using a propane torch to dry the wood. A neighbor thought the propane torch was a danger to a dwelling, and charges of attempt to burn a dwelling and attempted arson were brought against me. I would NEVER attempt to burn a dwelling or



commit arson! Ultimately the charges were dismissed. It was a he-said/she-said kind of court situation. I maintain that the propane torch was harmless to any dwelling within a stone's throw of the fire. I never ended up even starting the fire - I only attempted to dry the wood. A very unfortunate misunderstanding altogether.
