What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

CLIENT WAS REFERRED TO ME BECAUSE SHE OBJECTED TO THE HIGH PREMIUM MEDICARE MEDICAL AND PART D INSURANCE PLANS WHICH WERE SOLD TO HER BY SOMEONE ELSE. SHE ASKED ME TO RECOMMEND LOWER PREMIUM PLANS. I EXPLAINED TO HER THAT HER CURRENT MEDICAL PLAN HAD NO CO-PAYS AND THAT A LOWER PREMIUM PLAN WOULD HAVE CO-PAYS. SHE LEARNED LATER THAT A CERTAIN MEDICAL PROCEDURE WHICH SHE REQUIRES HAS A 20% CO-INSURANCE AND THAT THE FULL COST OF THIS PROCEDURE IS QUITE HIGH. SHE ALLEGED THAT I RECOMMENDED AN UNSUITABLE MEDICAL PLAN BECAUSE HER COST WAS MUCH HIGHER THAN UNDER THE NO CO-PAY PLAN SHE HAD BEFORE. I DON'T REMEMBER THAT SHE DESCRIBED THE MEDICAL PROCEDURE AND WOULD HAVE HAD NO KNOWLEDGE OF THE FULL COST OF THE PROCEDURE OR WHAT HER COST-SHARING AMOUNT WOULD HAVE BEEN. THE COMMISSIONER STAYED THE CIVIL PENALTY BUT I WAS ASSESSED INVESTIGATIVE COSTS OF \$146.25.
