IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations:	Customer alleges that the two variable annuities she purchased in July 2014 and April 2015 were not suitable and that the fees were not disclosed. Customer requests a refund of the funds invested.

Alleged Damages Amount Explanation (if amount not exact):	The damages amount was not clearly specified. Customer requested a refund of the funds invested. As of 8/21/2015, customer deposited a total of \$324,961.22 into the two contracts, the total cash surrender value of the contracts was \$296,673.29 and the total amount withdrawn from the contracts was \$2,000. Thus the damages were calculated at \$26,287.93 (\$324,961.22-\$296,673.29-\$2,000).

Broker Statement

An investigation into this complaint was concluded by Thrivent Financial on November 5, 2015. Their conclusion was communicated at that time to the complainant in writing and stated that fees were disclosed by Financial Representative Robert J Baker and that the variable annuity investments he recommended to the complainant were suitable investments. In this same communique Thrivent stated that Mr. Baker was not guilty of having committed any sales practice violations. The complainant then took the matter to Idaho State. After review, without admitting liability and for the sole purpose of settling this dispute, Thrivent agreed to return customer's original investment back to her minus prior amounts withdrawn. Ultimately, after customer withdrew the cash surrender value and the prior withdrawals taken were accounted for, Thrivent ended up reimbursing customer a total of \$12,984.26.
