**Broker Statement**

THE WRITTEN COMPLAINT WAS INVESTIGATED AND DENIED ON 7/31/2013. WHILE THE COMPLAINT WAS STILL PENDING, THE CUSTOMER FILED A PETITION TO THE COURT ON 7/18/2013.

CUSTOMER PURCHASED A WHOLE LIFE POLICY IN 2011, PAID PREMIUMS FOR TWO YEARS, THEN INFORMED ME THAT SHE NO LONGER WANTED THE POLICY IN FEBRUARY OF 2013. THE CUSTOMER SUBMITTED A WRITTEN COMPLAINT THROUGH HER ATTORNEY TO THE FIRM IN JUNE OF 2013 MAKING CLAIMS AND DEMANDS. THE WRITTEN COMPLAINT WAS INVESTIGATED AND DENIED BY THE FIRM ON 7/31/2013. WHILE THE COMPLAINT WAS STILL PENDING, THE CUSTOMER FILED A PETITION TO THE COURT ON 7/18/2013. THE LAW SUIT PROCEEDED THROUGH A LEGAL PROCESS FOR A PERIOD OF ABOUT SIXTEEN MONTHS; IT WAS MEDIATED BEFORE THE SCHEDULED TRIAL DATE, A SETTLEMENT WAS REACHED. THE SETTLEMENT IS NOT AN ADMISSION OF LIABILITY AND SHALL NOT BE DEEMED OR CONSIDERED AS SUCH BY ANYONE FOR ANY PURPOSE.
