What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

 Call was made with the client at this request and with full permission due to issues with online account link. I did not "pose" as the client but the firm refused to conduct a proper investigation. Client was never contacted by Merrill to offer his actual statement to prove otherwise. No complaints were ever initiated by the client or any related party in reference to the call. The firm simply accused me of impersonation and began to make additional false blanket accusations without proof. As it became clear I was being targeted for harassment, I decided to resign voluntarily due to the way I was being treated.
