What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: Without admitting or denying the findings, Mogol consented to the sanctions and to the entry of findings that he initiated through his member firm brokerage account electronic transfers totaling approximately \$85,000 to transfer money from his personal bank account to his firm brokerage account knowing that his bank account lacked sufficient funds to cover the transfers. The findings stated that Mogol used the funds credited to his brokerage account before the transfers were reversed due to insufficient funds. When the transfers were reversed, Mogol deposited sufficient funds to cover the outstanding balances so neither the bank nor his firm incurred any losses.
