### Where did this information come from?

The complaint was determined to be without merit and denied by the firm. I had an excellent relationship with this customer for over twelve years. Unfortunately, the customer opted to move her accounts in 2020 while the markets were still recovering from the Covid pandemic. The complaint asked for reimbursement for the post-Covid unrealized losses in her two accounts. The firm denied the complaint and noted that I had provided sound financial advice and quality service to the client, and that the customer's accounts were significantly profitable for her on the whole and well-served her investment objectives over the years. There firm found no basis to offer an accommodation to the customer.
