IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement	Client provided verbal authorization to approve transfer request from his assistant. Client's assistant forwarded wire instruction to Morgan Stanley that originated from clients compromised personal email address. Representative confirmed via phone with client's assistant as client was unavailable that this was an authorized wire request. As client's assistant was not reflected on the account as an authorized individual, representative chose client's name as person confirming wire request on wire transfer system. Letter of Authorization confirming client's assistant was authorized to confirm wire request was not on file. However, client provided verbal



consent to financial advisor, and support staff that his assistant was able to confirm wire requests in his absence.
