IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

**Broker Statement** WHILE THE CLIENT DID NOT SPECIFY WHICH INVESTMENT HE WAS REFERRING TO THE FA INDICATED THAT SEVERAL BONDS WERE PURCHASED WHILE THE ACCOUNT WAS AT THE BRANCH. THE FA RECALLED DISCUSSING THE BONDS WHEN THE CLIENT NOTICED A DECREASE IN VALUE. THE FA EXPLAINED THAT ALTHOUGH THE VALUES



MAY HAVE FLUCTUATED INTEREST WAS STILL BEING PAID AND THE CLIENT'S PRIMARY OBJECTIVE WAS TAX FREE INCOME. IT WAS RECOMMENDED THAT THE INVESTMENTS BE HELD AT THAT TIME. THE FA STATED THAT THERE WAS NO GUARANTEE AGAINST LOSS GIVEN. IT DOES NOT APPEAR AS THOUGH THIS MATTER WAS HANDLED IMPROPERLY AND, AS SUCH, THERE WILL BE NO ADJUSTMENTS MADE AT THIS TIME.
