IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

FA STATED HE FOLLOWED CLIENT'S DIRECTIONS TO DISCUSS OPTIONS WITH HER DAUGHTER. HE CONFIRMED THE INSTRUCTIONS WITH CLIENT, AND DID EVERYTHING POSSIBLE TO EXECUTE THE INSTRUCTIONS IN A TIMELY MANNER, EXPLAINING NUMEROUS TIMES THAT PAPERWORK MAY BE REQUIRED. IT IS OUR UNDERSTANDING THAT AN APPOINTMENT HAD BEEN SET FOR THE FOLLOWING MONDAY TO COMPLETE ANY NECESSARY PAPERWORK. VARIABLE ANNUITY ORDERS DO NOT EXECUTE DURING NORMAL TRADING HOURS, BUT AFTER THE MARKET CLOSES, SO THAT THE UNIT VALUE MAY BE DETERMINED. IF INSTRUCTIONS WERE RECEIVED DURING TRADING HOURS, THE TRADE WOULD GENERALLY BE PRICED AT THE CLOSE OF BUSINESS THAT DAY. IF INSTRUCTIONS WERE RECEIVED AFTER TRADING HOURS, THE TRADE WOULD GENERALLY BE PRICED AT THE CLOSE OF THE NEXT BUSINESS DAY, AS WAS THE CASE WITH THE LINCOLN TRANSACTION. IT IS CLEAR THAT FA DID NOT INTENTIONALLY DELAY A TRANSACTION EXECUTION; ON THE CONTRARY, THE BRANCH DID EVERYTHING POSSIBLE TO FOLLOW CLIENT'S INSTRUCTIONS EFFICIENTLY, AS WELL AS MAINTAIN EXPECTATIONS OF HIS ABILITY TO EXECUTE THE TRANSACTION. THE TRANSACTION EXECUTED BASED ON A SERIES OF PROCESSES, BEYOND THE ADVISORS CONTROL. CLAIM DENIED.
