What is included in a IAPD report?

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Regulator Statement On October 8, 2014, the Office of Financial Regulation entered a Final Order against Scot A. Bennett for engaging in prohibited business practices by failing to send clients itemized invoices, comply with the custody requirements of the Florida Securities and Investor Protection Act, Chapter 517, Florida Statutes, and entering into client advisory agreements that did not accurately disclose advisory rates. Scot A. Bennett agreed to pay an administrative fine of \$8,000 jointly and severally with SAB Group Financial, P.A.
