WITH REGARD TO THE FIXED ANNUITY, THEY LIKED THE FACT THAT IT HAD NO MARKET VOLATILITY, 15% ANNUAL WITHDRAWAL PRIVILEGES WITHOUT PENALTY, AND THE NURSING HOME WAIVER AS WELL AS THE DEATH BENEFIT. TO MAKE SURE THE CLIENT UNDERSTOOD THE TRANSACTION, MY MANAGER CALLED TO VERIFY THAT THE CLIENT UNDERSTOOD THE NATURE OF THE PRODUCTS. AFTER THE PHONE CALL, HE WAS SATISFIED THAT THEY FULLY UNDERSTOOD THEIR INVESTMENT DECISION.
