What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

This action was from a business loan due to a business failure stemming from the 2008/2009 economic recession. Every attempt was made to avoid defaulting on this loan. The recession destroyed the revenue streams supporting the payment of the note to East West Bank. Counsel representing me in this case, made several attempts to settle this case. Attempts to settle were unsuccessful. East West Bank informed my counsel in early 2015, they were no longer pursuing collections efforts and the case was closed. No collection activity has occurred since early 2015. Counsel has recommended taking no action and letting the judgment expire in March 2026. Counsel does not expect East West Bank to renew the judgment when the judgment expires March 2026. This judgment has had no impact on my ability to provide advisory services and adequately and independently serve advisory clients.
