### What is included in a IAPD report?

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Westward Partners' Managing Members all serve as board members with all or most of the privately-held companies held in Westward Partners' fund portfolios and this work is deemed to be an integral component of Westward Partners' management role relating to the funds. While technically an outside activity, Mr. Tolzmann serves on the boards of these companies in his capacity as a Managing Member of Westward Partners and all board compensation is paid to Westward Partners pursuant to a written agreement. As he considered this work to be part of his ongoing management role with Westward Partners, he spends as much time as is needed to fulfill the services provided to these privately-held companies both during and outside of trading hours.
