IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement OUR REVIEW FOUND THE ADVISOR'S RECOMMENDATIONS WERE SUITABLE BASED ON THE CLIENTS' STATED GOALS AND OBJECTIVES. THE CLIENTS WERE 48 AND 46 YEARS OLD WHEN THEY BEGAN WORKING WITH THE ADVISOR IN 2000. THEY EXPRESSED A DESIRE TO RETIRE IN 7 YEARS. BASED ON THEIR HOLDINGS AT THE TIME, THE ADVISOR



INFORMED THEM THAT THEY HAD INSUFFICIENT ASSETS TO LAST THROUGH RETIREMENT WITHOUT TAKING ON MORE RISK WITH THEIR INVESTMENT OR LOWERING THEIR STANDARD OF LIVING DURING RETIREMENT. THE CLIENTS OPTED TO PURSUE A MODERATELY AGGRESSIVE STRATEGY. ONCE THE MARKETS BEGAN TO DECLINE, THEY REQUESTED REALLOCATION TO MORE CONSERVATIVE POSITIONS.
