What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Employing firm when activities occurred which led to the complaint: WACHOVIA SECURITIES, LLC

Allegations: FLORIDA CLIENT STATES THAT HIS FINANCIAL ADVISOR, JASON DUBLER, FAILED TO PLACE AN ORDER FOR THE SALE OF FMCN GIVEN ON THE MORNING OF 11/8/2007 UNTIL LATER THE SAME AFTERNOON, RESULTING IN A LOSS ESTIMATED BY THE CLIENT AT \$100,000. CLIENT ALSO STATES HE WAS NOT INFORMED BY MR. DUBLER THAT HIS SALE OF CHL, SOHU, SINA AND BHP STOCK ON 11/8/2007 WOULD RESULT IN THE COVERED CALLS HE HAD OPEN ON THE SAME POSITIONS BECOMING UNCOVERED. THIS IMBALANCE CAUSED THE SALES TO BE REVERSED BY FIRM POLICY ON 11/9/2007, CREATING AN ADDITIONAL LOSS CLIENT ESTIMATES AT \$140,000.
