IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: THE CLIENT COMPLAINED ABOUT THE CUSTOMER SERVICE THAT SHE WAS RECEIVING FROM THIS BRANCH OFFICE, BUT ALSO COMPLAINED THAT MR. BREWER MISREPRESENTED INFORMATION TO HER IN DECEMBER 2004, WHICH CAUSED HER TO SELL HER SHARES OF PPL.THE CLIENT ALSO ALLEGED THAT SHE DID NOT RECEIVE A PROSPECTUS ON HER PURCHASE OF THE CAPITAL INCOME BUILDER AND GOLDMAN SACHS' FUNDS.

Broker Statement THE CLIENT WAS MISTAKEN ON HER DATES, SINCE THE IR WAS OUT OF THE COUNTRY ON A DIVERSIFICATION TRIP. THE IR STATED THAT HE FELT



HIS MISTAKE WAS NOT CALLING HER AS SOON AS HE RETURNED TO THE OFFICE. THE IR ADVISED THAT THE CLIENT OWNED THE CAPITAL INCOME BUILDER FUND IN HER IRA ACCOUNT SINCE 2003 AND SHOULD HAVE RECEIVED SEVERAL PROSPECTUSES ON THIS FUND. HE DID RECALL THAT SHE REQUESTED A COPY OF THE GOLDMAN SACHS PROSPECTUS , BUT IT WAS LATE ON A FRIDAY AFTERNOON AND HE FORGOT . IT HAS SINCE BEEN MAILED. THE IR ADVISED THAT HE HAD PREVIOUS DISCUSSIONS WITH THE CLIENT ABOUT THE AMOUNT OF UTILITY STOCKS THAT MADE UP HER PORTFOLIO. HE COMMENTED THAT SHE CAME TO HIS OFFICE IN DECEMBER 2004 AND WAS CONCERNED ABOUT THE VOLATILITY OF HER PORTFOLIO AND THESE UTILITY COMPANIES. AT THAT TIME, SHE HAD APPROXIMATELY 86% OF THE VALUE OF HER ACCOUNT IN UTILITY STOCKS AND 57% OF THAT AMOUNT WAS IN PPL. MR. BREWER SUGGESTED SELLING OFF THE PPL TO DIVERSIFY HER PORTFOLIO AND REDUCE THE VOLATILITY IN HER ACCOUNT. THEY DISCUSSED SELLING A PORTION IN 2004 AND THE BALANCE IN 2005 , BUT WHEN THE TIME CAME TO SELL, THE CLIENT AUTHORIZED THE SALE OF ALL OF THE SHARES. THE IR ADVISED THAT THE CLIENT INHERITED THESE SHARES FROM HER HUSBAND AND THEY SHOULD HAVE HAD A STEPPED UP COST BASIS. HE PROVIDED HER WITH HISTORICAL PRICING INFORMATION ON THESE SHARES. THE IR STATED THAT HE NEVER SAID EDWARD JONES HAD A SELL ON THESE SHARES, SINCE WE DON'T EVEN COVER THE STOCK. HE ALSO STATED THAT HE DID NOT ADVISE HER THAT PPL WAS HAVING FINANCIAL TROUBLE. THE IR ADVISED THAT SHE SELL THESE SHARES MERLEY TO DIVERSIFY HER PORTFOLIO. THE CLAIM WAS DENIED.
