What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

Retirement-aged, attorney customer newly diagnosed with serious illness, complained of frustration that account returns did not match those of a sibling investing elsewhere, then later re-characterized frustration as a claim for conversion of a greater percentage of account positions to cash during a planned account rebalancing than was specifically authorized. Though the contention was strongly disputed, the firm's insurer opted to settle, pre-litigation, for \$13,750 on a cost of a potential defense basis
