What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Investment Adviser Representative Comment:	I AM DISPUTING THE REASON FOR TERMINATION AND U5 LANGUAGE. MY COMPLIANCE FILE WITH AXA IS FILLED WITH INACCURACIES. THERE ARE NAMES OF PEOPLE ON MY FILE THAT ARE NOT MY CLIENTS. MOST OF THE COMPLAINTS LISTED ARE COMPLAINTS AGAINST AXA'S SERVICE CENTER AND NOT DIRECT ALLEGATIONS AGAINST MY SALES PRACTICES. I HAVE BEEN DISPUTING MY COMPLIANCE HISTORY WITH AXA SINCE 2003, BUT THE COMPANY FAILED TO TAKE ACTION TO CORRECT MY COMPLIANCE HISTORY. IN ADDITION, THE ALLEGED UNSUITABLE SALE OF A FIXED LIFE INSURANCE POLICY TO A CUSTOMER IS INACCURATE. THE SALE WAS APPROVED BY AXA BRANCH COMPLIANCE PRIOR TO POLICY ISSUANCE. I HAVE PROPERLY FOLLOWED AXA'S CORRECT REPLACEMENT PROCEDURES. THE LEGAL ATTORNEY OF AXA HASTILY TERMINATED MY EMPLOYMENT WITHOUT COMPLETE DOCUMENTATION, FACTS AND ADEPT KNOWLEDGE OF AXA'S REPLACEMENT PROCESS. THEREFORE, AXA'S ACT OF TERMINATING ME BASED ON MY COMPLIANCE HISTORY AND ALLEGED UNSUITABLE SALE WAS UNFAIR AND WITHOUT MERIT.
