IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

This section provides information regarding a customer dispute that was reported to the Investment Adviser Registration Depository (IARD) by the Investment Adviser Representative (IAR), an investment adviser and/or securities firm, and/or a securities regulator. The event may include a consumer-initiated, investment-related complaint, arbitration proceeding or civil suit that contains allegations of sales practice violations against the individual.

The customer dispute may be pending or may have resulted in a civil judgment, arbitration award, monetary settlement, closure without action, withdrawal, dismissal, denial, or other outcome.

Employing firm when activities occurred which led to the complaint: EDWARD JONES

Allegations: THE CLIENT STATES THAT ON 8/2/06 THE IR INFORMED THEM OF A WAY TO INCREASE THEIR MONTHLY INCOME. THE RECOMMENDATION WAS TO WITHDRAW FUNDS FROM THEIR ANNUITY AND INVEST THE MONEY INTO VARIOUS FUNDS THAT WOULD PRODUCE MONTHLY INCOME. THE CLIENT CLAIMS THEY INQUIRED ABOUT THE EFFECT WITHDRAWALS WOULD HAVE ON THE DEATH BENEFIT, HOWEVER, THE IR STATED THAT THEY COULD WITHDRAW \$92,000 LEAVING \$26,083.96 WHICH WOULD GUARANTEE THE DEATH BENEFIT IN THE AMOUNT OF \$100,000. THE CLIENT STATES THAT ON 8/24 THE IR HAD \$92,600 WITHDRAWN FROM THE ANNUITY AND DISTRIBUTED INTO SEVERAL OTHER INVESTMENTS. IN OCTOBER, THE CLIENT STATES THEY RECEIVED A STATEMENT FROM THE ANNUITY SHOWING THE DEATH BENEFIT IN THE AMOUNT OF \$42,003.68. THE CLIENTS EXPRESSED THEIR CONCERN, HOWEVER, CLAIM THE IR DID NOT FOLLOW UP IN A TIMELY MANNER. THE CLIENTS CLAIM THEY LEARNED FROM THE INSURANCE COMPANY THAT THEIR WITHDRAWALS WERE NOT "DOLLAR FOR DOLLAR" BUT WERE A PROPORTIONATE WITHDRAWAL. IN ADDITION, THEY WERE TOLD TAXES WOULD HAVE TO BE PAID ON THE \$45,884.20 THAT WAS WITHDRAWN. THE CLIENTS FEEL THEY SHOULD NOT HAVE TO PAY THE TAXES OR CAPITAL GAINS ON ANY INCREASES FROM THE INVESTMENTS MADE WITH THE \$92,600.
