What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

I HAVE ADDITIONALLY REVIEWED CONCERNS INVOLVING INVESTMENT IN OAKWOOD MEDICAL INVESTORS. OUR RECORDS INDICATE THIS WAS PURCHASED IN SEPT 2000. AT THE TIME OF PURCHASE CLIENT EXECUTED A SUBSCRIPTION AGREEMENT AND A PROSPECTUS WAS PROVIDED. THE PROSPECTUS PROVIDED ALL OF THE INFORMATION PERTAINING TO INVESTMENT TO INCLUDE RISKS AND LIMITED MARKETABILITY. ADDITIONALLY, CLIENT ACKNOWLEDGED IN THE SUBSCRIPTION AGREEMENT HIS FINANCIAL ABILITY (NET WORTH, ETC.) TO MAKE THE INVESTMENT AS WELL AS HAVING SUFFICIENT EXPERIENCE IN BUSINESS, FINANCIAL AND INVESTMENT MATTERS TO BE ABLE TO EVALUATE THE RISK INVOLVED WITH THIS INVESTMENT.
