IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: THE CLIENT STATES COWGILL RECOMMENDED HE MOVE \$10,000 FROM EACH OF HIS ANNUITY CONTRACTS ADVISERS SUB-ACCOUNTS. THE \$20,000 WAS REINVESTED INTO TWO PUTNAM FUND B SHARES. THE CLIENT STATES HE WAS NOT MADE AWARE THAT THESE TRANSACTIONS WOULD RESULT IN A TAX CONSEQUENCE AND THERE WAS NO SUGGESTION THAT HE SEEK TAX ADVICE. THE CLIENT STATES THAT IN MARCH 2000 \$64,000 WAS LIQUIDATED FROM LIBERTY COLONIAL FUNDS CLASS A AND INVESTED INTO THE HARTFORD LEADERS VARIABLE ANNUITY. THE CLIENT QUESTIONS THE RECOMMENDATIONS. THE CLIENT REQUESTS \$10,382 IN REIMBURSEMENT FOR THE DIFFERENCE IN FEDERAL AND STATE TAXES AS A RESULT OF THE ANNUITY WITHDRAWALS, THE CDSC CHARGES AND ESTIMATED TAXES IN 2001.

Broker Statement	COWGILL (IR) STATED CLIENT INDICATED HE WISHED TO INVST MORE AGGRESSIVELY FROM 6/99 WHICH IR STATED SHE DID NOT RECOMMEND. IR STATED SHE EXPLAINED THE RISK ASSOCIATED WITH THIS TYPE OF ACTIVITY & SUGGESTED CLIENT STAY WITH CURRENT INVS. IR STATED CLIENT WAS AWARE CHANGES TO THE ANNUITY SUB-ACCOUNTS COULD BE MADE & THIS WAS DONE FOR HIM ON MORE THAN ONE OCCASION; CLIENT HAD RCVD DISTRIBUTIONS FROM HIS ANNS AT LEAST SINCE 1998 & HAD RCVD 1099R TAX FORMS IN PRIOR YRS INDICATING THE HE WAS AWARE THE DISTRIBUTION FROM THE ANNS CREATED A TAXABLE EVENT. IR STATED HE WAS SHOWN THE FUNDS AVAILABLE WITH THE SUB-ACCTS AND, AT HIS REQUEST, WAS ALSO SHOWN MFDS OUTSIDE THE ANN; CLIENT PICKED THE FDS WITH THE HIGHEST RETURNS & IR STATED SHE MADE IT VERY CLEAR THESE FUNDS WERE NOT WITHIN THE ANN. IR STATED HE INFORMED HER HE WISHED TO USE ASSETS WITHIN HIS PORTFOLIO TO PAY FOR THE MFD PURCHASES & SHE THEREFORE REVIEWED THE AREAS WITHIN THE ACCOUNT WHICH REFLECTED GAINS; THE ANNUITIES REFLECTED THE GREATEST GAINS & HE CHOSE THE ANN IN WHICH TO WITHDRAW FUNDS TO PAY FOR THE TRDS. IR STATED SHE DID NOT INITIATE THE COLONIAL FD LIQUIDATION AND FURTHER INDICATED SHE MET WITH THE CLIENT AFTER HE HAD VISITED WITH HIS TAX ADVSR; CLIENT INDICATED HE DID NOT WISH TO CONTINUE PAYING TAXES ON THE COLONIAL FUNDS AND HIS TAX ADVSR STATED HE NEEDED TO SELL THE FUND AND PLACE IN A TAX SHELTERED INV. IR STATED SHE REVIEWED THE IMPORTANCE OF BEING DIVERSIFIED AND THAT THE COLONIAL FUND HAD PERFORMED WELL, HOWEVER, THE CLIENT DIRECTED IR TO PURCHASE AN ANN. IR STATED SHE ALWAYS ADVISED THE CLIENT TO SPEAK WITH HIS TAX ADVSR WHEN MAKING ANY CHANGES TO HIS ACCT; CLIENT WOULD HAVE RECEIVED TRD CONFIRMS (AND PROSPECTUSES) ON THE MFDS PURCHASED AS WELL AS EDWARD JONES CUSTOMER STMTS WHICH REFLECTS ALL ACTIVITY IN THE ACCT. IN ADDITION, HE WOULD HAVE RECEIVED STMTS FROM THE ISSUER OF THE ANNS (HARTFORD) INDICATING THE WITHDRAWALS FROM THE ANNS. CLAIM DENIED.
