What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

THE BANK OF BLUE VALLEY CD PREVIOUSLY HELD IN THE ACCOUNT MATURED ON 03/20/09. THE DISCOVER BANK CD PREVIOUSLY HELD IN THE ACCOUNT WAS SOLD ON 03/16/09. THE PROCEEDS WERE SUBSEQUENTLY UTILIZED TO PURCHASE A FHLMC NOTE. THE FA HAS INDICATED HE SPOKE WITH THE HUSBAND AT THE TIME AND RECEIVED HIS AUTHORIZATION TO PLACE THE TRADES. IN REGARD TO THE 06/09 ACTIVITY IN BOTH OF THE ACCOUNTS, THE FA HAS INDICATED HE ORIGINALLY SPOKE WITH THE CLIENT REGARDING THE TRANSACTIONS THAT WERE COMPLETED IN THE JOINT REGISTRATION ACCOUNT. THE FA HAS FURTHER INDICATED HE EXPLAINED THE CLIENT HAD AN OPPORTUNITY TO LIQUIDATE THE CDS HELD IN THE ACCOUNT UTILIZING THE PROCEEDS TO PURCHASE CMOS (AT DISCOUNTS) WITH AN ESTATE FEATURE. THE FA HAS STATED HE RECEIVED THE CLIENT'S AUTHORIZATION AND THE TRADES WERE PLACED. AT THE TIME OF THE TRANSACTIONS, THE CLIENT WOULD HAVE RECEIVED CONFIRMATIONS DETAILING THE TRADES. IN ADDITION, ALL ACTIVITY HAS BEEN REFLECTED ON ACCOUNT STATEMENTS. AS PREVIOUSLY MENTIONED, THE CMOS WERE PURCHASED AT DISCOUNTS; THEREFORE, REDEEMING THE INVESTMENTS UNDER THE ESTATE FEATURE SHOULD RESULT IN SIGNIFICANT GAINS. WHILE IT IS OUR OPINION THAT THE FA MADE HIS SUGGESTIONS IN GOOD FAITH, WE ARE EXTENDING AN OFFER TO THE CLIENT TO SELL THE CMOS (WITH NO COMMISSION) PURCHASED IN JUNE 2009 IN EACH OF THE ACCOUNTS. UNFORTUNATELY, WE ARE NOT ABLE TO REINSTATE THE CDS THAT WERE PREVIOUSLY HELD IN THE ACCOUNTS. HOWEVER, WE WILL AGREE TO REIMBURSE THE ACCOUNTS FOR ANY OF THE CMOS THAT ARE SOLD AT A PRICE LOWER THAN THAT AT WHICH THEY WERE PURCHASED. CLIENT HAS THIRTY DAYS TO RESPOND TO OUR OFFER. CLIENT ACCEPTED OUR OFFER AND THE CMOS WERE SOLD WITH NO COMMISSION. THE PROCEEDS FROM THE TRANSACTIONS RESULTED IN A NET GAIN IN BOTH ACCOUNTS; THEREFORE, NO FURTHER ADJUSTMENTS WILL BE MADE.
