### Arbitration Information

#### Broker Statement

This dispute was between the client and Wells Fargo. The alleged infraction occurred more than 10 years ago. Wells Fargo chose to settle the case without my input. I was interviewed as part of their internal investigation, however, no allegations were made against me by the client.

The fact that the client did not receive the annuity program he expected is not in dispute, the reason why is still unclear. There was a difference between the physical application that the client and I filled out and signed together and the electronic system that Wells Fargo used to submit the application to John Hancock. Wells Fargo was never able to explain the discrepancy.
