**Broker Statement**

The disclosure should be removed as it is erroneous. Walter Wittrock was not involved in the matter covered by the disclosure.

In 2002, Walter Wittrock has informed the SEC about a fraudulent conduct of Freedom Financial and Associated Investment Management. Wanting this matter to be reflected in other reports too, he erroneously marked this as a "customer complaint" in his Form U4 at that time, believing that what he made was disclosing this conduct of the mentioned firms to the SEC. As a result, the matter showed up as a "customer complaint" in his Form U4.

Since the disclosure was made in total error, this should be removed. There has never been a customer complaint initiated against Walter Wittrock.
