What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

THE FINANCIAL ADVISOR STATED THAT THE ACCOUNT WAS TRANSFERRED IN TO EDWARD JONES WITH APPROXIMATELY \$64,000 IN CDS, \$9,000 IN BONDS AND \$15,000 CASH. THE SUBSTANTIAL PORTION OF THE LIFE INSURANCE MONEY THE CLIENT MENTIONS HAD BEEN INVESTED PRIOR TO THE ACCOUNT BEING TRANSFERRED TO EDWARD JONES. THE FINANCIAL ADVISOR STATED THAT AS THE BONDS AND CDS WERE TO MATURE OR BE CALLED HE MADE RECOMMENDATIONS FOR REINVESTMENT. THE FINANCIAL ADVISOR STATED THAT REINVESTMENT INTO FRANKLIN MUTUAL FUNDS WAS DISCUSSED AND AUTHORIZED BY THE CLIENT. THE LOSSES EXPERIENCED IN THIS INVESTMENT ARE ATTRIBUTED TO THE MARKET CONDITIONS AND MARKET FLUCTUATION. THE FINANCIAL ADVISOR STATED THAT HE DID NOT RECALL THE CLIENT INQUIRING ABOUT ANNUITIES, HOWEVER, HE WOULD HAVE DISCUSSED THEM HAD INTEREST BEEN INDICATED. THE FINANCIAL ADVISOR ALSO STATED THAT HE DISCUSSED WITH THE CLIENT THAT THE RMD NEEDED TO BE TAKEN FROM THE DECEDENT IRA. THE FINANCIAL ADVISOR STATED HE WAS CAREFUL TO DISCUSS ALL DETAILS OF INVESTING TO ENSURE THE CLIENT'S UNDERSTANDING. IT APPEARS AS THOUGH THESE MATTERS HAVE BEEN HANDLED PROPERLY AND AS SUCH REQUEST FOR REIMBURSEMENT WAS DENIED.
