What is included in a IAPD report?

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and

Allegations: THE CLIENT AND HIS ATTORNEY ALLEGE NOLLETTE PROVIDED THE CLIENT WITH AN INCOMPLETE SET OF DOCUMENTS, WHICH ARE REQUIRED FOR A LOST CERTIFICATE. THEY STATE A SECOND SET OF PAPERWORK WAS REQUESTED IN ORDER TO RECEIVE A REPLACEMENT CERTIFICATE WHICH CAUSED DELAYS. THE CLIENT ALSO ALLEGES THE CLIENT PURCHASED 10,000 SHARES OF LEVEL III, BASED UPON NOLLETTE'S REPRESENTATIONS THAT THE LOST CERTIFICATE AND THE LEVEL III STOCK WERE BOTH MARGINABLE. THE CLIENT STATES THE LOST CERTIFICATE WAS NOT MARGINABLE AND HE WOULD HAVE MADE HIS PURCHASE OF LEVEL III ON A CASH BASIS AT ANOTHER FIRM HAD HE KNOWN THE STOCK WAS NOT MARGINABLE. THE CLIENT IS REQUESTING A RESCISSION OF THE 10,000 SHARES OF LEVEL III PURCHASED ON JULY 2, 2001.

THE 07/02/01 PURCHASE OF LVLТ WAS EFFECTED THROUGH THE CASH ACCOUNT. NOLLETTE RECEIVED APPROVAL, ON AN EXCEPTION BASIS, ON 07/05/01 TO MARGIN THE SECURITY AND THE ORDER WAS REBILLED TO THE MARGIN ACCOUNT. NOLLETTE STATES HE ADVISED THE CLIENT THE ADDITIONAL 5,000 SHARES OF LVLТ, WHICH WERE REPORTED AS LOST, WOULD NOT BE MARGINABLE UNTIL THE REPLACEMENT CERTIFICATE WAS RECEIVED INTO THE ACCOUNT. THE CLIENT RECEIVED A MARGIN CALL AND ON 07/19/01 DEPOSITED \$1,331 INTO THE ACCOUNT. IT APPEARS NOLLETTE HANDLED THE SITUATION APPROPRIATELY AND ADVISED THE CLIENT CORRECTLY WITH REGARD TO THE LOST CERTIFICATE. THE CLIENTS REQUEST TO RESCIND THEIR PURCHASE OF 10,000 SHARES OF LVLТ HAS BEEN DENIED., THE SECURITY RECEIVE AREA ADVISED THEY HAD RECEIVED NOTIFICATION ON JULY 18 OF A TYPO ON THE AFFADAVIT FOR THE LOST CERTIFICATE. THE CORRECTED PAPERWORK WAS FEDERAL EXPRESSED ON 07/19/01 AND THE REPLACEMENT CERTIFICATE WAS ISSUED ON 08/08/01. ALTHOUGH IT DOES NOT APPEAR THE TYPO DELAYED THE LOST CERTIFICATE STATUS, WE HAVE NONETHELESS AGREED TO REIMBURSE THE CLIENT \$106.43, REPRESENTING THE MARGIN INTEREST CHARGED TO THE ACCOUNT.
