What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

On August 31, 2018 I renewed my Minnesota resident insurance license online through the state of Minnesota website. In good faith, I stated I had completed the necessary and required number of continuing education hours under the assumption I had done so. I was notified after renewal that I had indeed not completed the necessary number of hours. I promptly completed the outstanding hours and paid an additional "late" fee for renewal. At the beginning of September 2018 I received a letter from the state of Minnesota informing me of a \$500 civil penalty for renewing my license while not having completed the necessary continuing education hours. I agreed to and paid the penalty to the state of Minnesota.
