What is included in a IAPD report?

Where did this information come from?

Broker Statement

I deny any wrongdoing and assert that the customer's allegations are completely without merit. The customer had invested in the same types of investment he complains about here twice before, and these investments generated a 30% profit. In each instance, the features, benefits, and all risks of recommended investments were fully discussed with and acknowledged by the client prior to purchase, and his total investments in this asset class represented only 2% the client's liquid net worth. Furthermore, the client received, read, and acknowledged suitability and understanding of the features, benefits, and all risks of recommended investments by signing applicable disclosure forms which detailed the potential for liquidity restrictions and the potential for investment losses. Although I am not personally named in this matter, I intend to assist LPL in defending against these false allegations.

Employing firm when activities occurred which led to the complaint: NORTHEAST SECURITIES, INC.

Allegations: UNSUITABLE INVESTMENTS PURCHASED AT HOME (ATHM) ON 12/7/99 AND PLANET RX (PLRX) ON 11/2/99. THE ALLEGATION OF PURCHASING INVESTMENTS WAS A RETALIATORY ACTION BY THE CLIENT BECAUSE I TERMINATED MY ENGAGEMENT AS THEIR CPA FOR NOT DEPOSITING OR REPORTING MORE THAN 50% OF THEIR INCOME EARNED FROM THEIR BUSINESS. SHE INVESTED OVER \$100,000 IN A START UP RESTAURANT, THEREFORE SHE WAS NOT ADVERSE TO RISK. I PURCHASED AT-HOME COMMUNICATIONS AND PLANETRX, BASED ON FAVORABLE EXPECTATIONS OF THE COVERING ANALYSTS. I TERMINATED THE PROFESSIONAL RELATIONSHIP IN MARCH OF 2000, SHE SUBSEQUENTLY FILED A COMPLAINT IN APRIL DURING THE SPRING MARKET DECLINE. I SETTLED THE COMPLAINT BY PURCHASING THE STOCK FROM THEM AT THE ORIGINAL PURCHASE PRICE.
