**Broker Statement**

The client surrendered her variable annuity after only one year when another insurance agent recommended that she should 1035 exchange her variable to a fixed indexed annuity with another carrier. The client was provided a prospectus, detailed contract explaining all surrender charges at the time of investment. The insurance agent executed the transfer on behalf of the client despite significant surrender penalties. Despite the broker-dealer Raymond James finding no fault in Mr. Pacitti, as a sign of good faith they offered to settle the claim. Additionally, the client requested that her mutual funds were sold and transferred to the indexed annuity. The mutual funds were sold the next day during unprecedented market volatility in 2008 which resulted in additional losses. The losses due to a one-day delay of selling the mutual funds were refunded to the client at the bequest of Gregory Pacitti to honor his commitment to excellent service.

The client invested part of his equity and mutual fund portfolio into a variable annuity in order to stay fully invested, but now have a guaranteed minimum death benefit to protect his estate. He fully understood the additional expense incurred to secure a guaranteed death benefit as it was discussed in detail and the primary reason for the investment in this product. When his health deteriorated and his son took over his finances, his son did not agree that the additional expenses for a guaranteed death benefit was of value and wished to surrender the policy immediately. This was denied.
