IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Allegations: 04/26/10-06/08-10: THE CLIENTS STATE THEY DID NOT KNOW WHAT WAS BEING SIGNED AT THE TIME THE ADVISORY SOLUTIONS ACCOUNT WAS CREATED. THEY STATE THE FA DID NOT PROVIDE A COPY OF WHAT WAS SIGNED AT THE MEETING ON 4/26/10. THEY ARE NOT HAPPY WITH THE FA AND BEGAN THE PROCESS OF TRANSFERRING THEIR ACCOUNTS. THEY STATE THE ASSETS WERE PURCHASED IN THE ACCOUNT ON THE SAME DATE THE FA RECEIVED NOTIFICATION THE ACCOUNTS WERE TRANSFERRING. THEY STATE THEY HAVE RECEIVED POOR SERVICE FROM THE FA. THE CLIENTS ALSO INDICATE THEY WERE NOT AWARE \$50,000 WAS BEING PLACED IN AN ANNUITY. THEY STATE THE FA CHANGED ACCOUNT NUMBERS WHEN HE FOUND OUT THEY WERE TRANSFERRING. THEY WOULD LIKE TO BE REIMBURSED FROM THE TIME THEIR ACCOUNTS WERE CHANGED FROM THE OLD ACCOUNTS TO NEW ACCOUNTS; THEY INDICATE LOSSES ARE APPROXIMATELY \$7000.

ACCORDING TO THE FA, HE REVIEWED THE TYPE OF ACCOUNT THE CLIENT WAS OPENING AND WHY IT WAS BEING SUGGESTED. ADDITIONALLY, THE CLIENT SIGNED THE AUTHORIZATION, ADOPTION AGREEMENT AND BENEFICIARY DESIGNATION FORM ON 4/26/10. THIS FORM OPENED THE NEW ACCOUNT AND REFLECTED THE NEW ACCOUNT NUMBER. OUR RECORDS INDICATE THE SECURITIES WERE SOLD IN THE ACCOUNTS WITH NO COMMISSION AND THE PROCEEDS WERE TRANSFERRED TO THE NEW ACCOUNT ON 5/7/10. ON 5/12/10, THE ACCOUNT WAS APPROVED AS AN ADVISORY SOLUTIONS ACCOUNT AND, PER THE AGREEMENT SIGNED, ASSETS WERE PURCHASED WITH NO COMMISSION. THE CLIENT SIGNED THE AUTHORIZATION TO PURCHASE THE VARIABLE ANNUITY IN THE IRA ACCOUNT. PER HIS REQUEST, THE CLIENT EXERCISED THE FREE LOOK. THE FA INDICATED HE CALLED THE CLIENT BACK WHEN THE CLIENT REQUESTED A CALLBACK. BASED ON OUR REVIEW, IT APPEARS THE CLIENT WAS INFORMED A NEW ACCOUNT WOULD BE OPENED AND FUNDS TRANSFERRED FROM THE PREVIOUS ACCOUNTS. THE NECESSARY PAPERWORK WAS SIGNED TO OPEN THE ACCOUNT AND INVEST ACCORDING TO THE ADVISORY SOLUTION PAPERWORK ALSO SIGNED BY THE CLIENT IN LIGHT OF THESE CIRCUMSTANCES, THE CLIENT'S REQUEST FOR REIMBURSEMENT IS RESPECTFULLY DENIED.
