THE HEARING PANEL ISSUED THE PENALTY, CONSENTED TO BY RAFAEL, OF A CENSURE AND A \$6,000 FINE. RAFAEL DISCLOSED ON HIS FORM THAT HE ATTENDED COLLEGE FROM 1966 TO 1967.
