What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

THE CLIENT HAS STATED THAT SHE REQUESTED TO CASH OUT AND HAVE THE FUNDS SENT TO HER ON HER IRA. ON NOVEMBER 10, 2008, THE CLIENT CALLED EXPRESSING HER CONCERN WITH THE MARKET AND WE DISCUSSED CURRENT VOLATILITY AND DECIDED TO MAKE NO CHANGE TO HER PORTFOLIO AT THAT TIME. SHE DECIDED TO STAY FULLY INVESTED. ON NOVEMBER 21, 2008, WE DISCUSSED THE CONTINUED VOLATILITY AND SHE REQUESTED THAT HER INVESTMENTS BE LIQUIDATED & MOVED TO A MONEY MARKET ACCOUNT. THE FUNDS WERE PLACED IN A GOVERNMENT MONEY MARKET FUND AT THAT TIME. I MADE 7 ATTEMPTS FROM JAN 09 - JULY 09 TO DISCUSS A STRATEGY OF MOVING THE FUNDS BACK INTO THE MARKET. ON AUGUST 31ST 2009, AFTER A DISCUSSION WITH THE CLIENT, I RECOMMENDED THAT SHE TRANSFER HER FUNDS TO A BANK CD BECAUSE SHE DIDN'T HAVE THE COMFORT OF BEING IN THE MARKET BUT WANTED A HIGHER YIELD. THE CLIENT PHONED IN MAY 7, 2010 REQUESTING HER RMD, I SUGGESTED AGAIN THAT SHE TRANSFER HER FUNDS TO A BANK CD AND SHE DIDN'T WANT TO MAKE THAT MOVE. I PHONED THE CLIENT ON JUNE 2ND, 2010 REQUESTING THAT SHE TRANSFER HER FUNDS TO HER BANK. BASED ON A DETAILED AUDIT OF THE ACCOUNT, THE ONLY FUNDS DISTRIBUTED FROM THE IRA WAS HER RMD.
