WATSON ADVISED A SENIOR CITIZEN TO INITIATE A 1035 EXCHANGE OF AN EXISTING, MATURE, VARIABLE ANNUITY INTO A EQUITY INDEXED ANNUITY. THIS CUSTOMER NEEDED MORE LIQUIDITY THAN THE NEW ANNUITY ALLOWED, AND THEREFORE, THE STATE ALLEGED A VIOLATION OF RULE 130.853 UNDER THE ILLINOIS SECURITIES LAW REGARDING UNSUITABLE SECURITY TRANSACTIONS. THE STATE ALSO ALLEGED THAT WATSON FAILED TO UPDATE QUESTION 14.F OF HIS CRD FOR U4, IN VIOLATION OF SECTION 12.E OF THE ILLINOIS SECURITIES ACT.
