IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

WHEN I MET THE CLIENT IN 2003 AT WM FINANCIAL HE WAS UNHAPPY WITH HIS WADDELL & REED BROKER AND THE VOLATILITY OF A NATIONWIDE VA THAT HIS BROKER RECOMMENDED. THE CLIENT WANTED TO IMMEDIATELY MOVE THESE FUNDS INTO CD'S. I EXPLAINED POTENTIAL TAX IMPLICATIONS, PENALTIES AND SUGGESTED A 1035 TRANSFER. I TOLD THE CLIENT TO SEEK THE ADVICE OF HIS DAUGHTER (POA) AND A TAX ADVISOR BEFORE TAKING ANY ACTION.

THE CLIENT DECIDED TO SURRENDER THE VA. THEREAFTER, WE DISCUSSED SEVERAL INVESTMENT OPTIONS INCLUDING MUTUAL FUNDS, CD'S AND A FIXED ANNUITY. BASED ON THE CLIENT'S STATED INVESTMENT OBJECTIVES, HE APPROVED THE PURCHASE OF MUTUAL FUNDS AND AN AIG FIXED ANNUITY. AT THAT TIME, I REMINDED THE CLIENT OF OUR PRIOR CONVERSATION ABOUT 1035 TRANSFERS. HOWEVER, BASED ON HIS INITIAL GOAL TO BUY CD'S, HE DID NOT CONSIDER A 1035. REGARDING THE AIG APPLICATION, I INADVERTENTLY CHECKED THE BOX REFLECTING A "REPLACEMENT". NEVERTHELESS, MY ERROR DID NOT ALTER THE CLIENT'S TAXABLE EVENT.

THE ALLEGATIONS OF THE CLIENT'S POA ARE FALSE AND HAVE NO MERIT. ALL INVESTMENT ADVICE WAS SUITABLE AND I MADE FULL DISCLOSURE BOTH VERBALLY AND IN WRITING OF ALL MATERIAL FACTS. THE POA HAS NOT PROVIDED DOCUMENTS TO SUPPORT THE ALLEGED TAX LOSS AND SURRENDER FEE. THE CLAIM HAS BEEN DENIED.
