IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

CLIENT STATES THE ORIGINAL POLICY WAS TO COVER FINAL EXPENSES AND FA SUGGESTED A LARGER BENEFIT OF \$50,000 (VS \$15,830) COULD ALSO PROVIDE FOR HER CHILDREN. CLIENT STATES SHE DID NOT REALIZE FUNDS WOULD BE DIVERTED FROM HER INVESTMENT ACCOUNT TO PAY THE PREMIUMS. CLIENT INDICATES DURING THE FALL OF THE MARKET IN 2008, HER PORTFOLIO SUFFERED AND IN 2010 THE FA RECOMMENDED TO TERMINATE THE POLICY AS IT BECAME UNAFFORDABLE. CLIENT STATES A NUMBER OF ISSUES SURROUNDING THE PURCHASE OF THE HARTFORD POLICY: SUITABILITY, AFFORDABILITY, PROPER DISCLOSURE, COMPLIANCE, TAX STATUS AND FINANCIAL LOSS.
