What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: CLIENT ALLEGES THAT THE REPRESENTATIVE ADVISED HER THAT THE VARIABLE ANNUITY THAT SHE PURCHASED IN JANUARY 2007 INCLUDED A GUARANTEE OF PRINCIPAL. CLIENT CONCEDES THAT EVEN AFTER REVIEWING THE CONTRACT AND IRA DISCLOSURE STATEMENT SHE STILL BELIEVED SHE WAS INVESTED IN A FIXED ACCOUNT AND COULD NOT LOSE PRINCIPAL. HOWEVER, CLIENT NOW ALLEGES THAT AFTER LOOKING MORE CLOSELY AT HER ACCOUNT SHE HAS LEARNED THAT HER FUNDS ARE NOT FULLY INVESTED IN A FIXED ACCOUNT, AND HAS LOST NEARLY 50% OF HER PRINCIPAL. CLIENT REQUESTS A FULL REFUND OF HER INVESTMENTS.
