What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

CHEVIRON THEN TOOK THESE FUNDS TO ANOTHER BRANCH OF THE BANK WHERE HE DEPOSITED IT INTO HIS OWN PERSONAL ACCOUNT. CHEVIRON ULTIMATELY USED THE CUSTOMER'S FUNDS TO MAKE HOME IMPROVEMENTS TO HIS PERSONAL RESIDENCE. CHEVIRON'S MEMBER FIRM COMPENSATED THE CUSTOMER FOR THE FUNDS WRONGFULLY TAKEN FROM HER ACCOUNT. CHEVIRON HAS NOT REIMBURSED THE FIRM. IN ADDITION, CHEVIRON, WITHOUT PERMISSION OR AUTHORITY, WRONGFULLY CONVERTED AND USED AT LEAST \$21,931.08, DRAWN FROM THE FIXED ANNUITY OF TWO CUSTOMERS. CHEVIRON CAUSED THE CUSTOMERS TO SIGN DISTRIBUTION REQUESTS TO AN INSURANCE COMPANY WITH INSTRUCTIONS TO MAIL CHECKS TO CHEVIRON'S ATTENTION AT TWO BANKS AND CHEVIRON'S PERSONAL RESIDENCE. UPON RECEIPT, CHEVIRON DEPOSITED THESE FUNDS INTO HIS PERSONAL BANK ACCOUNTS AND USED THE FUNDS FOR HIS OWN PERSONAL BENEFIT. IN AN EFFORT TO CONCEAL THAT HE WAS THE BENEFICIARY OF THE CUSTOMERS' FUNDS, CHEVIRON CREATED FALSE ACCOUNT STATEMENTS, WHICH HE PROVIDED TO ONE OF THE CUSTOMERS.
