IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations:

THE CLIENT STATES THAT HE CONTACTED THE FINANCIAL ADVISOR AS HE WANTED TO TRANSFER HIS ACCOUNT FROM MORGAN STANLEY. THE CLIENT STATES THAT THE FINANCIAL ADVISOR STATED HE COULD NOT TRANSFER. THE CLIENT STATES THAT HE WAS GIVEN THE IMPRESSION THAT HER ORIGINAL BROKER WOULD HAVE TO LIQUIDATE THE STOCKS HE HAD PURCHASED AND THEN THE EDWARD JONES FINANCIAL ADVISOR WOULD PURCHASE "MUCH BETTER PERFORMING FUNDS". THE CLIENT STATES THAT HE DID NOT WANT DIFFERENT FUNDS; JUST WANTED TO TO SELL THE ONES HE HAD AT THE RIGHT TIME. THIS OCURRED IN 2004. THE CLIENT STATES THAT HE NOW HAS LOOKED OVER HIS LAST STATEMENT FROM MORGAN STANLEY AND SEES THAT THE FINANCIAL ADVISOR DID HAVE EVERYTHING TRANSFERRED AND TOOK A COMMISSION ON THE SELL AS WELL AS THE PURCHASE OF NEW FUNDS. COMMISSIONS ON THE BUYS WOULD HAVE EXCEEDED \$5,000.
