What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: This issue stems from the transfer of an IRA that got sent by mistake into a non-qualified account, creating a tax event for Ms. [REDACTED]. Once I realized what had occurred, I informed Ms. [REDACTED] that I maintained errors and omissions insurance and that I would immediately file a claim to cover her expenses from the error. Once I made that referral, I had no ability to direct, influence, or speed up the process. The process has recently concluded by Ms. [REDACTED] acceptance of compensation that satisfied her needs, which was paid for by the E&O carrier, and is what I assured her would happen from the beginning.
