What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

VIOLATIONS OF ARTICLE III, SECTIONS 1 AND 33, APPENDIX E, SECTION 16 OF THE RULES OF FAIR PRACTICE IN THAT THE FIRM, ACTING THROUGH ROWE, IN CONNECTION WITH THE FIRM'S ANNUAL AUDIT FOR FISCAL YEAR ENDING 10/31/85, IMPROPERLY CLASSIFIED FUNDS OF A LIMITED PARTNERSHIP IN WHICH ROWE FUNCTIONED AS GENERAL PARTNER AND IN WHICH THE FIRM WAS A LIMITED PARTNER AS AN ALLOWABLE ASSET AND IMPROPERLY NETTED A RECEIVABLE OFFSETTING TO A SHORT INVENTORY POSITION; ACCEPTED ORDERED FROM A CUSTOMER TO PURCHASE AND WRITE OPTION CONTRACTS PRIOR TO APPROVAL OF SUCH ACCOUNT BY THE FIRM'S REGISTERED OPTIONS PRINCIPAL; AND, FAILED TO INCLUDE CERTAIN TRADING INCOME IN ITS 1984 ASSESSMENT REPORT. DECISION RENDERED 7/27/87, WHEREIN RESPONDENTS ARE FINED \$2,000.00, JOINTLY AND SEVERALLY AND ASSESSED COSTS OF \$331.40, JOINTLY AND SEVERALLY. 8/24/87 - CALLED FOR REVIEW. BOARD OF GOVERNORS' DECISION RENDERED 3/3/88, WHEREIN FINDINGS ARE AFFIRMED AND THE SANCTIONS ARE MODIFIED; THEREFORE, RESPONDENTS MEMBER AND ROWE ARE CENSURED, FINED \$5,000.00 AND ASSESSED COSTS OF \$331.40, JOINTLY AND SEVERALLY. 4/2/88 - DECISION IS FINAL. ***\$5,331.40 J&S PAID ON 1/26/90 INVOICE #90-06-46*** 8/31/89-SEC NEWS DIGEST ISSUE 89-146, 8/2/89; SEC AFFIRMED DISCIPLINARY ACTION TAKEN BY NASD AGAINST THE FIRM AND ROWE. NASD CENSURED RESPONDENTS AND FINED THEM \$5,000, JOINTLY AND SEVERALLY. SEC FOUND THAT APPLICANTS FAILED TO COMPLY WITH CERTAIN REPORTING REQUIREMENTS, AND THAT THE FIRM VIOLATED SUPERVISORY PROVISIONS GOVERNING CUSTOMERS' OPTIONS ACCOUNTS.
