IN JANUARY OF 2007, I TRANSFERRED BACK TO SOUTHERN CALIFORNIA GIVING UP ALL MY CLIENTS AND LEAVING THEM WITH A LOCAL BROKER WITH THE FIRM TO MANAGE. IN DECEMBER OF 2007, THE CLIENT CALLED THE TRADING DESK TO LIQUIDATE HIS FUND, BUT WAS RECOMMENDED NOT TO BECAUSE THE FUND WAS A COUPLE OF DAYS AWAY FROM THE ONE YEAR ANNIVERSARY AND THE CLIENT WOULD BE SUBJECT TO A 1% CDSC. INSTEAD OF MOVING THE CLIENT TO THE MONEY MARKET FOR A COUPLE OF DAYS THEN LIQUIDATING, THE CLIENT WAS RECOMMENDED TO PUT THE MONEY BACK IN THE FUND AND WAIT FOR THE NEXT TENDER DATE. IT WAS DURING THIS TIME AT THE BEGINNING OF 2008 WHERE THE CLIENT'S ACCOUNT VALUE REALLY DECLINED AND HE VERBALLY COMPLAINT. AT THE TIME OF THE COMPLAINT I WAS NOT THE BROKER OF RECORD FOR HE ACCOUNT AND DID NOT HAVE CONTACT WITH THE CLIENT FOR OVER A YEAR. FULL AND FAIR DISCLOSURE WAS GIVEN TO THE CLIENT AT THE TIME OF PURCHASE AND HE WAS HAPPY WITH THE VALUE OF HIS ACCOUNT WHEN HE CALLED THE TRADING DESK.
